Terms and Conditions

CONSUMER RIGHT CANCELLATION

Buyer's right to cancel. You (the Buyer) may cancel this Agreement by sending notice to Just Be Fit Fitness Center, L.L.C. before midnight of the 3rd day (excluding Saturday, Sundays and legal Holidays) after the day you signed the Agreement. MEMBERSHIP

Memberships are not transferable and fees will not be refunded except at the sole discretion of Just Be Fit Fitness Center, L.L.C. Officers and Management. Use of membership card by a non-member could result in the cancellation of the agreement with no refund.

CARDS

There will be a \$10.00 fee charge for replacing a lost card.

GUESTS

TANNING BEDS

Tanning Beds may be used only during posted staff hours or if staffed after hours by an employee of Just Be Fit Fitness Center, L.L.C.

LOCKERS

ATTIRE
